In view of above, all State Governments are requested for strict compliance of the instruction of the Ministry and accordingly ensure that admission of students in AYUSH –Under Graduate courses shall be mandatorily through the merit list of National Eligibility cum Entrance Test (NEET) from the Academic Year 2018-19.

Sir,

In reference to this Ministry's order number R-13040/33/2016-HD (Tech) Para dated 25.01.2016, the Ministry has received representations from certain State Governments expressing their inability to admit student into AYUSH-UG courses for the Academic Year 2017-18 as GBSI; has not included the AYUSH-UG courses in its notification. In this regard, the Ministry has also received representations about allowing the management/ NRI quota as it is being permitted for MBBS/BDS seats. The matter was examined by the Ministry and after considering the representations made by the State Governments, it has been decided to convey that:-

- i. Since, it is important to ensure that meritorious students / candidates come to AYUSH estreams of medicine, it would be advisable to the State/UT Government to adopt the merit list of National Eligibility cum Entrance Test (NEET) for admission in AYUSH UG courses for the A.Y. 2017-18 as per the existing reservation policies of the concerned State Government in tune with CBSE notification of NEET for modern medicine.
- ni. However, if due to some difficulties the State/UT Governments are unable to adopt NEET merit list for AYUSH UG admission for A.Y. 2017-18, then such States/UT Government may admit students in all the AYUSH Colleges/Institutions (Public and Private) through Common Entrance Test (CET) of the concerned State Government as per the existing Rules and Policies of the concerned State/UT/Institute/University as done in the previous year (2016-17).
- iii. Admission in AYUSH UG Courses shall be compulsorily through NEET merit list from the A.Y. 2018-19.
